**Payment Option 1:** Pay **monthly installments** in the amount of \$\_\_\_\_\_. The remaining 8 payments are due monthly, beginning September 2018 and ending April 2019. A fee of **\$20** will be assessed for all payments made after the 10<sup>th</sup> of each month unless prior arrangements have been made. The School may suspend or terminate a student in its sole discretion if at any time tuition payments are more than 30 days delinquent.

**Payment Option 2:** Pay the **full year's tuition** in one payment by May 1, 2018, to receive a 3% discount. \$\_\_\_\_\_ No extensions please.

**Tuition and Fees** are calculated on an annual basis. There are no reductions for holidays, vacations, staff work days, student absences or illness. No credit or refund will be owed if the school must close due to emergency or inclement weather

\_\_\_\_ I understand this contract is for the **2018-2019** school year. I am obligated to pay tuition regardless of absences for any reason; provided, however, that a student may withdraw from the school at any time with 30 days' prior notice in writing. A student re-enrolling after such withdrawal, if space is available, will be treated as a new enrollment and will be subject to all the policies and requirements applicable to any new student.

\_\_\_\_ A provisional 6 week adjustment period is required before final acceptance of all new students. If the School determines the child is not ready for the program; charges will be assessed only for the days the student has attended.

\_\_\_\_ I agree to provide written notice to the School at least thirty (30) days prior to changing to a different Extended Day Plan, and I understand that having done so, I may not, during this school year, change to another Plan.
